8. Elgin Park Redevelopment Update

- Chair Brocanier referenced a recent media advisory that was shared on January 19th regarding the beginning of construction activity.
- Rebecca Carman indicated that tenants have been notified of the start of construction.
- Successful proponent was Dalren Limited.
- The Major Capital Projects team will attend NCHC meetings bi-monthly (starting in February) in order to provide project updates.
- Staff plan to organize a media announcement within the next few months.



- Rebecca Carman provided further background information, highlighting that the project is being led by the NCHC in partnership with Northumberland County.
- The Elgin Park Redevelopment Project will increase the number of subsidized and attainable market rental housing units at this location from 18 to 40 units in total.
- In addition to 12 market rental units, there will be 28 subsidized units an increase of ten over the current availability at this site.
- Rebecca Carman reminded directors that media inquiries can be directed to Chair Brocanier.
- The application for RGI housing can be done through the County's Subsidized Housing Page.
- Staff are still working through the process for market renal unit applications.
- NCHC Directors are to direct the public to the Elgin Park Redevelopment Project website for inquiries regarding the application process and project status updates (https://www.northumberland.ca/elginpark)
- Impacted tenants have been successfully relocated.
